This beautifully decorated flat presents a charming unusual layout that comprises an open-plan kitchen, a living area, two bedrooms, an office space, a corridor, a bathroom with a wall-hung toilet and a laundry area.

This property consists of two condominium units located in two different small condominiums built next to each other and managed separately by a voluntary group of co-owners ("syndic bénévole") each. The two condominium units are interiorly connected within the flat which unique access is possible only through one of the condominiums. This property is under the condominium status ("Bien vendu soumis au statut de la copropriété"). Agency fees are to be paid by the seller.


